

# AUSTRALIAN MADE COMPETITIONS

## TERMS & CONDITIONS

By entering an “Australian Made Competition” promotion, you are agreeing to the following terms and conditions:

### 1. STANDARD TERMS

1.1 Information on how to enter forms part of the terms of entry.

### 2. WHO CAN ENTER?

2.1 Subject to clause 2.2, entry is only open to residents of Australia. Must be able to show upon request proof of residency e.g. drivers licence.

2.2 Employees and their immediate families of Australian Made Campaign Ltd (the Promoter) and their associated agencies and companies are not eligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether by natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

### 3. HOW TO ENTER

3.2 In order to enter the competition entrants must complete the form and activity outlined at <https://www.australianmade.com.au/competitions>.

3.3 Entrants (including winners) in the competition may enter once only.

3.4 Entrants under the age of 18 years must obtain the prior permission of a parent or guardian over the age of 18 years before entering the competition.

### 4. PRIZES

4.1 Prizes are not redeemable for cash and will be forfeited if the winner is unable to claim the prize within seven working days of notification. If for any reason the winner does not take the prize or any element of the prize at the time stipulated by the Promoter, then the prize or any element of the prize will not be redeemable for cash.

4.2 In the event that a prize is forfeited after 7 days, Australian Made reserves the right to substitute the winner via a second draw. Australian Made will endeavour to contact the original winner of the prize before completing a redraw.

In the event that any prize item is unavailable, the Promoter reserves the right to substitute a prize item of equal or greater value.
